- One and two-family dwelling containing not more than 3,500 sq. feet of building area.
- Alterations and repair work determined by the plumbing official to be of a minor nature.
- Buildings with a required plumbing fixture count less than 12.
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

If work being performed is described above, check box below **Plans Not Required**.

**Plans are required** for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

**V. APPLICANT SIGNATURE**

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. **IX. INSTRUCTIONS FOR COMPLETING APPLICATION**

General: Plumbing work shall not be started until the application for permit has been filed with Clare County. All installations shall be in conformance with the State Plumbing Code. **No work shall be concealed until it has been inspected.** Call Clare County at 989.539.2741 to schedule an inspection providing as much advance notice as possible. You will need to provide the **job location** and **permit number**.

**Expiration of Permit:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

**Where to Submit Application:** Clare County is responsible for code enforcement throughout the County except in cities, villages or townships which have their own authority. Permit applications for County issued permits should be sent to the address on the front of this application. If you are unsure of where to obtain your permit please contact our office.
